



Lansdowne Children's Centre is a highly accredited children's treatment centre (CTC) and SmartStart Hub, connecting caregivers with resources, services & supports, for infants, children, and youth with physical, communication, and/or developmental needs. Team members work with children and their families in our centres in Brantford, Caledonia, Dunnville and Simcoe, and in a variety of community settings such as homes, schools, childcares and camps, as well as virtually through streaming video services.

Lansdowne has provided compassionate care and service delivery in the City of Brantford and the County of Brant since 1974, growing to support all families in the Grand Erie region including Haldimand and Norfolk counties, Six Nations of the Grand River, and Mississaugas of the Credit First Nation.

Lansdowne acknowledges we are on the traditional treaty and unceded territory of the Original People including the Attawanderon, Anishnaabe, and Haudenosaunee that has long been home to the Six Nations of the Grand River and the Mississaugas of the Credit First Nation.

We recognize their enduring connection as perpetual stewards of these lands protected by the "Dish with One Spoon" wampum agreement and the Haldimand Treaty, covering six miles either side of the Grand River along its length. In the spirit of these treaties, we seek to understand our place within history and build mindfulness of our present solidarity with Indigenous partners through relationships supporting families, so all children reach their potential.

This past year we ventured down memory lane with past and current friends and families of Lansdowne Children's Centre as we marked 50 years since incorporation, kicked off by past board leaders gathering on the anniversary date of receiving our Letters Patent.

We were honoured by the special guests who graced our halls during our 50th Anniversary Open House (September) and those who donned their formal wear to celebrate at our 50th anniversary Eras Gala (November).

The celebratory mode inspired innovative work during year two of our 2023 strategic plan, with gratitude for the partners who made this a productive year advancing on our priorities.

Innovating to ensure scarce resources reach the clients most efficiently, we implemented more 'tiered service' classrooms to enhance delivery of school-based rehabilitation.

While not externally visible, we appreciate government resources that are allowing us to advance plans for our new Brant-based Centre, as we get close to making public our future home's locale, while bolstering services at other sites to ensure close-to-home supports catchment-wide.

Who doesn't enjoy relaxing with a good story? The stories we share are the client journey and family successes. Moreso than storytelling, we most importantly first listen to those voices. The feedback we rely on from client families provides an essential dimension to gauging the value of our work.

More than just our outputs, which reflected positively with 6% more unique clients served [against 11% more unique referrals], our commitment to meaningful outcomes means meeting the promise of effective service. While we increased our caseload turnover rate with efficient discharges to bring more kids from waitlists into service, we must summon creativity to find innovative solutions to support families while navigating competitive labour market realities.

We honour the expertise and dedication of our skilled employee teams – our greatest asset – while maintaining an emphasis on retention and wellness. In thanking governance volunteers for their time in strategic board and committee deliberations, we also mourn the loss of our Treasurer, David Gowling, and several former board leaders this past year.

We honour all Lansdowne lives with gratitude for the opportunity to support every child reaching their potential.

How can we improve?

Through survey responses, the following feedback themes were identified:

1) Waitlist Concerns

Lansdowne will continue to develop services/Tiered services to support the diverse needs of our growing community of infants, children and youth, with focus on opportunities to connect more clients, more quickly with service, support and resources.

2) Client Communication

Lansdowne is seeking to manage and meet the communication expectations of clients, working with service providers on tools and procedures to enhance response time to inquiries.

3) Transition Support

Lansdowne is exploring how to better support clients and their families during transition, from elementary to high school, and high school to adulthood.

Equipment supports help kids to thrive

Isla Clarke is a vivacious kid with an active imagination; she's creative and likes to be busy.

Having been diagnosed with Cerebral Palsy (CP), she needs some equipment to help her be as active as she wants to be.

Through Lansdowne, Isla's family was able to facilitate getting equipment loaned to her preschool. This included things like a special chair that allowed Isla to join her classmates when they were seated at the table for activities or food, meaning "She's not left out," said her mom, Nicole.

It's not just that Lansdowne has helped get the equipment to the preschool, but a team member has also attended the preschool to teach educators how to use it properly.

"Which is huge, because I learned things when I was there that one day," Nicole said.

Lansdowne Early Intergration Program Resource Consultants work with educators in licensed childcare sites, Wee Watch and before and after school programs.

Developing artistic interests

Opportunities designed to assist and encourage, promoting growth and development.

Painting, acting, and dancing are just some of the ways a person can express their experience and their feelings, which is why the recreation arts programs are a cornerstone of Lansdowne.

At the June 19 annual general meeting, Isabelle Michalski was named the recipient of the Terry Fisher Art Student of the Year Award. This was in recognition of her active membership in the Artfelt Minds, Happiness Hikes and LCC Dance Crew programs.

Later in the year, on Nov. 28, the Therapeutic Recreation Artists' Gala highlighted the offerings of the Artfelt Minds Club, Lansdowne Lights Drama Club and the LCC Dance Crew.

In Therapeutic Recreation programs, Lansdowne clients can participate in their preferred leisure activities without the barriers that might exist in settings with less available support staff.

As Susan Battin, Autism Services manager, noted, people have been verbally expressing their appreciation for the updates to Lansdowne's front entrance and gym, "And we have a few non-verbal reactions as well from our little friends who often do not say a lot, and that says a lot in and of itself."

DeGroote Real Estate donation means more access

A \$10,000 donation from Adam DeGroote Real Estate Inc. made services more accessible for Lansdowne clients and their families. With the donation, Lansdowne purchased a new SMART board for the Entry to School program, which helps children diagnosed with Autism Spectrum Disorder become familiarized with the typical activities and routines of the classroom. Six iPad keyboards were also purchased, improving client-family access to wireless-device technology.

A YEAR OF CELEBRATION: 50TH ANNIVERSARY

In 2024, Lansdowne celebrated its 50 years of supporting the needs of infants, children and youth facing physical, communication and developmental challenges, and their families.

Throughout the year, there were a number of special events to mark the occasion.

On April 16, there was a special ceremony at 39 Mt. Pleasant Street, including past board members reaching back to 1974—when Lansdowne was founded in the school of the same name on Preston Blvd.—as well as representatives from the Grand Erie District School Board (GEDSB) and the Rotary Club of Brantford, were invited to come together to mark the occasion.

Later in the year, on Sept. 18, local dignitaries, current and past clients and their families, as well as the community at large were invited to an open house at Lansdowne's Brantford site, where they could tour the facilities and learn more about the work the agency does.

The signature event of the year-long celebration was the Eras Gala on Nov. 16 at the Brantford Golf and Country Club. The night told the story of Lansdowne, from its precursor organizations to its present-day successes.

Gratitude to GIVING

Tenley, 11, has been attending Lansdowne Children's Centre for child development since infancy. She was diagnosed with lissencephaly, which means 'smooth brain,' because with the condition, a person's brain doesn't have the same folds and ridges that one normally sees. As a result of her condition, "(Tenley) has global developmental delays; she has seizures, epilepsy."

Tenley's mom, Julie Neal, is a real estate agent, owner of Style Haven Home Décor, and volunteers as a board member for Lansdowne Children's Centre Foundation.

At Lansdowne, Neal found support for her family, and received instruction in physiotherapy, occupational therapy, and speech therapy, to help Tenley develop abilities and realize her potential. "They hold a very special place in my heart ... We would have been completely lost without Lansdowne."


"Not all communities have a place like Lansdowne,"

Neal added, noting that while it's been a huge part of her and her family's life, there are still plenty of people who haven't heard of Lansdowne and have no idea about the work it does. "I feel like if people understood what actually happened there, it would be unstoppable."

In November, Neal ran the inaugural Magic of Giving Holiday Market, which raised just under \$8,000 for the Foundation. Neal is planning to bring the market back again in 2025.

In 2024, Bob organized the "Great Northern Fishing Trip" and with a long list of fellows sharing his passion for making our community stronger, generated over \$200,000 in fundraising for the Rotary Club of Brantford—directing \$110,000 of that to Lansdowne Children's Centre Foundation.

This sort of organized effort is immensely impactful in furthering our ability to maintain, enhance and grow support efforts for children and youth, beyond clinical service. These are life-changing investments for our kids, who will have new opportunity to pursue independence, explore their interests and expand their skills.

A partnership with Smilezone Foundation, with donor Margaret Gurney, brought about a refreshed lobby and gymnasium at 39 Mt Pleasant St. In her words, "The Briaura Foundation and I are incredibly proud to support the Smilezone transformation at Lansdowne Children's Centre, and it is an honour to give back to the wonderful community of Brantford and Brant County." We are honoured by your great gift Margaret, thank you!







We were blessed this year to receive \$35,000 in legacy gifts from the estate of Helen Ross. Helen was an active member of the Brantford community, whose light shone bright on all that had the pleasure to know her well. We learned that Lansdowne was chosen as a recipient because one of Helen's great grandnieces had received support at Lansdowne and "the particular care that she got..." left an incredibly positive impression. 








Funding Sources 2024-25




